



REGISTRATIONS

Registration for the FMCSA Drug and Alcohol Clearinghouse (Clearinghouse) began for all user roles on September 28, 2019. Commercial driver's license (CDL) or commercial learner's permit (CLP) holders, employers, consortia/third-party administrators (C/TPAs), medical review officers (MROs), and substance abuse professionals (SAPs) all must register within the Clearinghouse. In some cases, a single user may have multiple roles within the Clearinghouse.



QUERIES



Queries Conducted Monthly Comparison (November)



VIOLATIONS REPORTED TO CLEARINGHOUSE

Employers or their designated C/TPA, and MROs are required to report violations of the drug and alcohol program in the Clearinghouse per § 382.705. Since January 6, 2020, there were 308,430 test results reported to the Clearinghouse with violations.







Return to Duty Process

If a CDL/CLP holder has a drug and alcohol program violation recorded in the Clearinghouse, the CDL/CLP holder must be removed from safety-sensitive functions, including operating a commercial motor vehicle, until the return-to-duty (RTD) process is completed. Select milestones of a driver's RTD process are recorded in the Clearinghouse. The table below provides a snapshot of the number of drivers in the RTD process with their status in the Clearinghouse as of December 1, 2024.


